## STREETSBORO ALUMNI ASSOCIATION Minutes June 27, 2009

The annual meeting of the Streetsboro Alumni Association was brought to order at 7:50 p.m. by President Mack.

President Mack welcomed special guest Harry Taylor who celebrated his 50 year anniversary of graduating from high school. President Mack also thanked Jane Reynolds for the use of her home during last year annual alumni association meeting.

Three Board of Directors attended the Streetsboro Area Chamber of Commerce howcase and Business Expo on Saturday afternoon, September 27, 2008. We had a table available to sell shirts, hats, and passed out membership envelopes and signed up two new lifetime members.

Mr. Szumski, Membership Chairperson went to the Streetsboro High School omecoming dance and handed out the scholarship information to 100 students (9/27/2008) with information about the available alumni association scholarship.

We mailed out over 100 birthday cards to our members and other Streetsboro Alumni. We mailed out over 25 sympathy cards to alumni who have lost a loved one this year.

We put together the FOUR alumni association newsletters, July and October 2008, AND January and April 2009.

Mr. Szumski asked Joe Huber, the high school scholarship coordinator, to post some laminated notices about the alumni association scholarships on bulletin boards in the high school and place an alumni association promotional sign with membership envelopes in the entryway to the high school.

Next year we will also continue our presence at home football games and begin to include home basketball games.

We will continue to increase the amount of money raised to fund student scholarships.

I want to again thank my members of the Board of Directors for all of the work they have done this past year to make the Streetsboro Alumni Association the best and most progressive organization it can be.
