## President's Report

Hello Streetsboro Alumni. When I became president at last year's annual meeting, I proposed to do three things: 1) publish a quarterly newsletter, 2) increase membership, and 3) provide a \$250 scholarship to a graduating senior. All three of these items have been accomplished plus much more.

Our alumni association newsletter editor put together the FOUR alumni association newsletters, July and October 2007, AND January and April 2008. The newsletters list the names of new members, scholarship criteria, class reunion information and other items of interest to our alumni.

We have **more than doubled** the number of lifetime members.

One of the things the alumni association wants to do is increase the amount of money available for student scholarships. We worked with Todd Puster, the Streetsboro City Schools Treasurer. We wanted the Streetsboro Educational Foundation to act as our custodian for donated scholarship funds. This way the donor can deduct the donated funds from their income taxes. I signed the authorization letter and I forwarded it to Todd Puster for action by the Streetsboro Educational Foundation. Our proposal was accepted.

Mr. Szumski, Membership Chairperson, met with the Streetsboro High School seniors (9/25/2007) and told them of his experience after graduation from Streetsboro High School and also told them about the availability of the Streetsboro Alumni Association scholarship. Vice President Ricki (Poole) Graeser assisted him passing out handbills with information about the available alumni association scholarship. We purchased advertising space in **The Orbiter**, the Streetsboro High School newspaper, announcing the alumni association scholarship. There were five candidates for this scholarship. The scholarship recipient was **Stacie Lesher** who will be attending Baldwin-Wallace College in the fall.

Let me end by giving a big **"THANK YOU"** to Jane Reynolds, SHS class of 1935, for hosting our alumni dinner and business meeting in her home. Thank You.
